## Simplified Model for the Establishment of Parent-Teacher Associations in Kindergartens

The Education Bureau (EDB) has all along been actively encouraging all schools to set up Parent-Teacher Associations (PTAs), with a view to enhancing the communication between parents and schools, promoting home-school co-operation and parent education, and joining hands to foster students' learning and whole-person development. To encourage more kindergartens (KGs) to establish PTAs, EDB introduces the "Simplified Model for the Establishment of Parent-Teacher Associations in Kindergartens" ("Simplified Model") starting from the 2023/24 school year. The "Simplified Model", available as an option for KGs, can streamline KGs' administrative and clerical work in establishing PTAs, and further support the formation of PTAs in KGs.

Under the "Simplified Model", kindergartens are not required to seek independent registration or draw up a constitution for the PTA. Nevertheless, to ensure smooth and effective operation, KGs must formulate an appropriate school-based mechanism (i.e. "Parent-Teacher Association Operational Guide") according to their school context as the basis for the formation and operation of the PTA. For the basic concepts of the "Simplified Model", steps to establish a PTA under the "Simplified Model", and suggested key contents and sample of the "Parent-Teacher Association Operational Guide", please refer to the Guidelines provided by EDB (see Annex).

To let principals and teachers of KGs better understand the key points relating to the
